2026 AAS Meeting overview

The 2026 AAS annual meeting will be held in Lincoln, Nebraska and hosted by Eileen Hebets. Eileen provided an outstanding and exciting overview of Lincoln. Dates for this meeting are TBD but will be posted on the AAS website.

Election Results:

Paula Cushing thanked the candidates who agreed to run during this year's AAS Governance Board election including:

Anne Danielson-Francois who ran unopposed for President Elect (because she and Jason Bond received a tie for this position two years ago).

Angela Chuang, David Nelsen, and Daniel Proud who all agreed to run for Director.

Nina Sandlin who ran unopposed for a continuation of her position as society treasurer.

Cushing applauded all these individuals for their willingness to serve and congratulated Anne Danielson-Francois, Angela Chuang, and Nina Sandlin for receiving majority votes for their respective positions.

Overview of Society:

Linda Rayor summarized the **changes to the Journal of Arachnology** (JoA) including implementing a new Pay on Demand option for members who wish to continue to receive hard copies of the journal. For the present, Lifetime Members who wish to receive hard copies will continue to do so without additional payment requirement.

Linda requested that authors who submit to JoA ensure that their article is polished and thoroughly checked. She pointed out that part of the delay in publication is due to minor corrections that the Editorial staff is required to do that authors miss. Authors should carefully follow the Instructions to Authors prior to submission.

Linda also provided an overview about positive changes to the society website.

Finances: She pointed out that AAS account are stable this year but costs and expenses will change over time. She encouraged members to increase their support for the society via donations and to encourage continued membership.

Currently, AAS has 309 regular **members**; 290 student and retiree members; and 80 sponsored members.

The society is moving to a more automated membership renewal system that will make renewing memberships easier.
